We have continued to hold a Book Draw at our Thursday lectures and, historically, the proceeds have supported art classes for young carers. Since April 2024, Book Draw proceeds are used to support The Arts Society Blackmore Vale's general finances.

- As last year, we held a fascinating Day of Special Interest at Cucklington Hall on 17 October, featuring Mary Alexander on John Singer Sargent. Our gratitude both to Hennie Walton for her imaginative topic selection and to Peter Evans for his innovative technical and projection skills. Our thanks (yet again) to Pippa Schofield for the delicious lunch and to all the team for their hard work.
- The New Members' Lunch in November was well-attended and very successful and the Christmas drinks after our December lecture was much enjoyed. Pippa Schofield again provided her brilliant sandwiches and snacks for these events. Thank you Pippa.
- Our 2025 Evening Celebration, also at Cucklington Hall was held on a hot evening in June. We began with drinks and canapés, followed by a fascinating and entertaining lecture on *The Queen Mother's Lifelong love of Jewellery*, given by Jeremy Mainwaring Burton. Pippa provided stunning canapés, Andrew Torrance, our Treasurer organised drinks and Georgina Scott ran the whole show to great effect including (for the second year) beautiful and much-admired displays of garden flowers. Once again, I cannot thank Georgina enough for her hard work and her creative thinking.
- Alix's Coffee Rota runs the refreshments for our lectures and has continued most successfully. We are very grateful to Alix and her team for their sterling work.
- In similar vein, we depend heavily on Anthea Payne's calm efficiency in dealing with all aspects of Membership, aided by her tick-in helpers especially Sally Bolton and Fiona McEwan.
- We continue to monitor and develop our website. Lincoln Waller, who last year
  was joined by Maggie Mowbray, are currently developing a Members' Area and
  are setting up a Facebook page. Our thanks to them both for keeping pace with
  the ever-increasing speed of developments in the digital world.
- Peter Evans is our energetic Projection Team leader. As with the website,
  Projection never stands still so the demands on him and his team (Mike Hall,
  Peter Williams and Lincoln) are relentless. Last year we reviewed our
  AudioVisual needs –necessary due to the increasing AV sophistication of our
  lecturers. Implementation has been delayed, partly due to changes in the panel
  of Stalbridge Hall Trustees, but we are hoping to make progress very soon.
- Pippa Schofield runs Arts Volunteering and is vice-Chair (as well as providing stellar lunches and canapés for our social events...). This year, we have financed an Arts Workshop, run by Briony Bricknell of Magic Lantern, at Bourton Primary School, funded by a £250 Community Grant from The Arts Society It is becoming almost impossible to get teachers and others to accept financial help for the arts. - Next year, we will again run a Day of Special Interest on 16 October plus another Summer Evening Celebration, in addition to our New Members' Lunch and Christmas drinks after our December lecture.

Turning to financial matters, we are pleased to report that, despite all challenges, careful management has allowed our finances for 2024-25 to again generate a small surplus. The Treasurer's Report describes how this has been achieved, but we should emphasise the role that digital communication has played. We are grateful for your increasing co-operation in using email and the website, so enabling us to keep costs down. As you know, most of our costs are unrelated to member numbers, so a larger number of members means more control over subscription levels. Our lecturers are still keeping their fees level, though this is unlikely to last for ever. To keep our

finances stable, we propose to keep the membership subscription for 2025-26 to its present level of £52.

Please also note the Treasurer, Andrew Torrance's comments on the GiftAid scheme in his report. As usual my sincerest thanks to Andrew for his calm and orderly management of our finances – a job which he has now done for 4 years.

Last year, The Arts Society's new Governance proposals, effectively disenfranchising individual societies, were soundly defeated. This led to all but one of the Trustees resigning and a new team being installed.

At Blackmore Vale, we believe that The Arts Society's most important asset is its panel of lecturers. To this end, Margaret has prepared another richly varied programme for 2025-26, details of which accompany this letter.

We ended our 2023-24 season with 138 members. Pre-pandemic, membership was 256. In 2024-25 membership has again dropped, and currently stands at 126. Last year, I outlined our twin problems of membership numbers plus the reluctance of members to get involved in running the Society. The committee roles for Minutes Secretary and for Publicity and Marketing have been vacant now for more than 4 years, and, by July 2026, all the current Committee will stand down, having served more than the recommended 3 years (in some cases much, much more).

Unless we can attract both new members and, even more crucially, new Committee members, The Arts Society Blackmore Vale will therefore have close at the end of the 2025-26 season. The Trustees will review the position at the end of September.

Running all these events and activities successfully depends on an enthusiastic team. The world around us is changing faster than ever and, more than ever, survival requires an innovative response. We need people with enthusiasm, expertise and creativity. If you think you can help, please get in touch with me at ann.tasker@gmail.com.
